2. General Discussion

Subject A. Discussion of the Mission Statement and Curriculum Committee Mission Statement

The Orange Coast College Mission Statement and Curriculum Committee Mission Statement were displayed and discussed in relation to curriculum approval.

Subject B. Curriculum Institute 2022

Lori Pullman presented information regarding Hyflex integrating in-person and virtual instruction. Michelle Grimes-Hillman added information regarding Saddleback offering live online and in-person. Fred Judd shared that he has a class that is live online, and some students come to campus to attend in person.

AB705 and 1705 were presented to get students to college-level English and Math.

AB928 and student transfer reform was discussed.

Elizabeth Page presented information on DEIA with classroom and curriculum applications. Baccalaureate degree proposals cannot be duplicated statewide. Michelle Grimes-Hillman provided some background information of the baccalaureate degrees at the community college level.

Melissa Rowden provided information about what majors the CSUs and UCs accept from community colleges. There was conversation at Curriculum Institute regarding moving past standards towards emotional learning and past individual accountability and towards group projects.

Michelle Grimes-Hillman stated that there will be some great opportunities for online instruction and the California Virtual campus. There will be some opportunities and discussion regarding low-cost materials and OER.

Manoj Wickremesinghe responded to Lori Campbell's question regarding OER and articulation. OER does not affect transfer UTCA or GE approval. Major prep articulation may be questioned.

Subject C. AB 928 and AB 1111

Lori Pullman discussed AB 1111; Common Course Numbering was discussed. We are currently waiting for direction from the state. C-ID is the current common course numbering system. Michelle Grimes-Hillman stated this will be a phased in approach built on what C-ID has done.

Michelle Grimes-Hillman stated the 34-unit pattern proposed with AB928 eliminates area E.

Subject D. Articulation Update

Manoj Wickremesinghe stated that the extended deadline for CSU and IGETC breadth is September 30th. IGETC Area 7 will be automatically approved if they are approved for CSU Area F.

Common course numbering was discussed at the district Articulation meeting. Manoj discussed AB 928 (Calgetc).

Elizabeth Page discussed the creation of 2023-2024 catalog timeline. Representative were reminded to speak with faculty regarding narrative revision for program modifications by attached to CurricUNET proposals. All CTE documentation is being uploaded to CurricUNET. Melissa Rowden discussed the proposed retirements that will be send out soon. The programs must also be modified if there is a retirement. Lori Pullman stated that we proactive and retire the course if there is no response.
